## PRODUCT DIRECTIONS

### EQUIPMENT TO USE

Spray bottle, mop and pail, sponge, cleaning cloths, and appropriate measuring devices.

### DIRECTIONS TO USE

**CAUTION:** Floors will be slippery when wet or contaminated with foreign materials. Promptly clean-up spills and foreign materials.  
**MOP AND BUCKET CLEAN:** 1. **MIXTURE:** Dilute 2 oz./gal. with cold water (1:64) for normal soil. Dilute 4 oz./gal. with cold water (1:32) for heavy soil. 2. **APPLICATION:** Apply solution to floor being cleaned. 3. Pick-up soil and excess cleaner with a tightly wrung-out cleaning mop. **SPRAY AND WIPE CLEANING:** 1. **MIXTURE:** Dilute 2 oz./gal. with cold water (1:64) for spray & wipe cleaning. 2. **APPLICATION:** Apply to surface being cleaned. 3. Wipe and let surface dry. **MACHINE CLEANING:** 1. **MIXTURES:** Dilute 1/2 oz./gal. with cold water (1:256) for daily scrubbing. Dilute 2 oz./gal. with cold water (1:64) for deep scrubbing. 2. **SCRUBBING:** Scrub with red pad daily. Double scrub with green/blue pad before recoating or restoring. 3. Trail mop machine turns, edges and low spots in the floor to pick up cleaning solution left behind by machine.
