PRODUCT DIRECTIONS

EQUIPMENT TO USE

Spray bottle or pail and mop, sponge, cleaning cloth, bowl mop, scrub brush, rubber gloves and eye protection.

DIRECTIONS TO USE

Remove heavy soil deposits from surface, then thoroughly wet surface with a use-solution of 2 oz. per gallon of water. The use-solution can be applied with a cloth, mop, sponge, or coarse spray or by soaking. For sprayer applications, use a coarse spray device. Spray 6-8 inches from the surface, rub with a brush, cloth or sponge. Do not breathe spray. Let solution remain on the surface for a minimum of 10 minutes. Rinse or allow to air dry. This product is not for use on food contact surfaces. Prepare a fresh use-solution daily or more often if the solution becomes visibly dirty or diluted.

Additional Information

Sanifect Plus 1 has demonstrated effectiveness against viruses similar to SARS-CoV-2 (COVID-19) on hard, non-porous surfaces. Therefore, this product can be used against SARS-CoV-2 (COVID-19) when used in accordance with the directions for use against Adenovirus on hard, non-porous surfaces.
