#### PRODUCT DIRECTIONS

### **EQUIPMENT TO USE**

Toilet bowl mop or swab, brush, eye protection, protective clothing, and chemical resistant gloves.

#### **DIRECTIONS TO USE**

Flush toilet. Add 3 ounces directly to water in toilet bowl. Brush to cover all interior surfaces of the bowl including under the rim. Allow disinfectant solution to remain for at least 10 minutes. Flush toilet. To clean badly stained bowls, repeat above treatment using 4 to 5 fluid ounces of this product. For use in urinals, add 3 ounces to 3/4 gallon of water. Apply by brush to all urinal surfaces. Allow disinfectant solution to remain at least 10 minutes. Flush.
